EXPERT EVIDENCE

I have reviewed the cases of both Plaintiffs and Defendants, in civil and criminal disputes, including those involving synthetic derivatives, insider trading, mis-selling, misuse of information, employment contracts, shareholder agreements, loan documents, disputes between banks and clients, setting of pricing, and determination of quantum.

I have been frequently appointed by Regulators, as a single or joint expert, and can bring in or wok alongside other experts, such as forensic accountants or liquidators.

I continue to develop my expert skills by training with, for instance, The Academy of Experts, London; the HK International Arbitration Centre; ADR International (Mediation); and the University of Monash/ Australian Advocacy Institute. I am a Practising Member of the Academy of Experts.

I am a long-term public speaker and lecture on financial matters for professional organisations around Asia and India. I authored the book, "Investment Insights" and my current interest is Behavioural Finance.
